Case Summary:

Rule 10 incident in the vecinity of the top mark. Also a request for redress for a penalty of rule 42 imposed by a jury during the incident.

Procedural Matters:

- 1. ARG 213312 did not come to the hearing, the hearing proceeded in accordance with RRS 63.3(b).
- 2. Piero Castañeda assisted the hearing as a witness of the incident.
- 3. At the begining of the hearing PER 211271 clarified that he intended to request redress for a situation conected to this protest. The IJ allowed the hearing to be changed from "protest" to "protest and request for redress" as permited by rule 64.1.c

Facts Found: -

- 1. PER 211271 on starboard tack and ARG 213312 on port tack were approaching the first upwind mark on converging course.
- 2. ARG 213312 was 1/2 boat length to leeward of the port layline. PER 211271 was fetching the mark on the starboard tack layline.
- 3. When they were at 1 metre distance, they were aiming bow to bow.
- 4. PER 211271 bore away sharply and past astern of ARG 213312 at 30 cm distance.
- 5. PER 211271 was penalized by a Jury for an infrigment of rule 42 just after he wore away
- 6. PER 211271 requested a redress for the yellow flag.

Conclusion & Rules:

- 1. ARG 213312 on port failed to keep clear of PER 211271 on starboard, and broke RRS 10.
- 2. PER 211271 place in race 5 was made significantly worse through her own fault. Therefore, the requirements for redress in RRS 62.1 are not met.

Decision:

- 1. DSQ ARG 213312 in race 5
- 2. Redress not given
